Here is the information I promised. It discusses two jail projects that Rosser International has designed recently. Both of them are projects that I think you will find interesting. Each is an addition to an existing jail. The first project is a \$55M addition to the Athens Clarke County jail in Athens, Georgia. The second is a \$16M addition to the Effingham County Jail in Springfield, Georgia. Both projects have been featured in nationally recognized detention publications.
